<b>Standard tour</b>	<p>a tour of the historical centre of Tábor; past the most significant architectural sights plus brief information about the town history (Žižka Square, old Town Hall, Jan Žižka Statue, fountain, burgher houses, Dean Church in Žižka Square, Tržní Square, Mikuláše z Husi Square, Kotnov and Bechyně Gate, mediaeval fortifications, a few words about Klokoty, St Filip and Jacob's Chapel, the River Lužnice, Jordán dam)</p> <p>(does not include admission fees in places of cultural interest, such as Hussite Museum, underground corridors, Kotnov Castle etc.)</p>

<b>Duration of the standard tour</b>	1.5 hours
<b>Above-standard tour</b>	it is possible to order a longer tour; we charge CZK 500 for every additional hour for tours in Czech and CZK 800 for tours in a foreign language
<b>Shorter tour</b>	tour less than 1.5 hours: the amount is charged the same as for a standard tour

<b>Number of people in a group</b>	1 – 45 people (if there are more people, two or more guides are needed)
<b>Where to meet the guide</b>	<p>At Infocentrum Město Tábor (tourist information centre), Žižka Square 2, Tábor (if the tour is held outside the office hours, meet the guide in front of the tourist information office)</p> <p>It is possible to arrange another meeting place, ideally located near hist. center (eg. in front of Bechyňská Gate - parking for tour buses loading and unloading)</p>
<b>Payment</b>	in cash in the tourist information office (before or after the tour) or by an invoice

	More than 1 day before the tour takes place: 0 % of the total amount		
	1 day before the tour: 50 % of the total amount		
	On the day of the tour and if the group does not show up at all: 100 % of the total amount		
	If the group is late, the time of the tour shall be reduced by the time by which the group was delayed. Full price shall be charged for such a tour.

It will assess whether it is possible to accept the changes and under what price conditions. Guide itself is not authorized to decide on changes and prices tours.*
